DETAILED ACTION

Response to Arguments

1. Applicant's arguments filled 6/6/2006 have been considered but are moot in view of the new ground(s) of rejection.

Claim Rejections - 35 USC § 103

- 2. The following is a quotation of 35 U.S.C. 103(a) which forms the basis for all obviousness rejections set forth in this Office action:
 - (a) A patent may not be obtained though the invention is not identically disclosed or described as set forth in section 102 of this title, if the differences between the subject matter sought to be patented and the prior art are such that the subject matter as a whole would have been obvious at the time the invention was made to a person having ordinary skill in the art to which said subject matter pertains. Patentability shall not be negatived by the manner in which the invention was made.
- 3. The factual inquiries set forth in *Graham* v. *John Deere Co.*, 383 U.S. 1, 148 USPQ 459 (1966), that are applied for establishing a background for determining obviousness under 35 U.S.C. 103(a) are summarized as follows:
 - 1. Determining the scope and contents of the prior art.
 - 2. Ascertaining the differences between the prior art and the claims at issue.
 - 3. Resolving the level of ordinary skill in the pertinent art.
 - 4. Considering objective evidence present in the application indicating obviousness or nonobviousness.
- 4. This application currently names joint inventors. In considering patentability of the claims under 35 U.S.C. 103(a), the examiner presumes that the subject matter of the various claims was commonly owned at the time any inventions covered therein were made absent any evidence to the contrary. Applicant is advised of the obligation under 37 CFR 1.56 to point out the inventor and invention dates of each claim that was not commonly owned at the time a later invention was made in order for the examiner to

consider the applicability of 35 U.S.C. 103(c) and potential 35 U.S.C. 102(e), (f) or (g) prior art under 35 U.S.C. 103(a).

5. Claims 1, 3-6, 9,11-14, and 17-22 are rejected under 35 U.S.C. 103(a) as being unpatentable over US Publication No. 2006/0190586 A1 to Stewart et al.(Stewart) in view of U S Patent No. 6160804 to Ahmed et al. (Ahmed).

Regarding claim 1, Stewart discloses a method of dynamically detecting a location of a mobile node (par. 9), comprising: accessing static information pertaining to the mobile node from a configuration database (pars. 12-14);

accessing dynamic information pertaining to the mobile node when the mobile node starts up (pars. 9-10); examining the static information and dynamic information pertaining to the mobile node; selecting a location module based on the information (pars. 12-14, and 16-17, using the received identification information memory is accessed to determine the network provider or network access);

However, Stewart fails to disclose executing the location module to determine whether the mobile node is on an intranet network or an external network separated from the intranet by a corporate demilitarized zone.

Ahmed discloses executing the location module to determine whether the mobile node is on an intranet network or an external network separated from the intranet by a corporate demilitarized zone (col. 4 lines 4-29, 48-60, and col. 6 line 56-col. 7 line 19).

Therefore, it would have been obvious to one of ordinary skill in the art at the time of the invention to modify the invention of Stewart, and have the location module to determine whether the mobile node is on an intranet network as disclosed by Ahmed for

the purpose of detecting position of the mobile devices for facilitating a possible network handoff.

Regarding claim 9, Stewart discloses an article comprising a machine-accessible medium having stored thereon instructions that, when executed by a mobile node (pars. 48-52), cause the mobile node to: access static information pertaining to the mobile node from a configuration database (pars. 43, 45, and 68-74); access dynamic information pertaining to the mobile node when the mobile node starts up (pars. 9-10, 38, 44, and 60-62); examine the static information and the dynamic information pertaining to a mobile node; select a location module based on the static information and the dynamic information (pars. 12-14, 16-17, 63, and 74-75, using the received identification information memory is accessed to determine the network provider or network access or access point);

However, Stewart fails to disclose executing the location module to determine whether the mobile node is on an intranet network or an external network separated from the intranet by a corporate demilitarized zone.

Ahmed discloses executing the location module to determine whether the mobile node is on an intranet network or an external network separated from the intranet by a corporate demilitarized zone (col. 4 lines 4-29, 48-60, and col. 6 line 56-col. 7 line 19).

Therefore, it would have been obvious to one of ordinary skill in the art at the time of the invention to modify the invention of Stewart, and have the location module to determine whether the mobile node is on an intranet network as disclosed by Ahmed for

the purpose of detecting position of the mobile devices for facilitating a possible network handoff.

Regarding claim 17, Stewart discloses a mobile node capable of dynamically determining its location (par. 47), comprising: a memory capable of storing a configuration database containing static information pertaining to the mobile node (pars. 47-52), the memory further capable of storing dynamic information obtained when the mobile node starts up (pars. 10, and 38); and a processor capable of executing an appropriate location module selected by a policy engine (pars. 48-51), the appropriate location module selected by the policy engine based on the static information and the dynamic information (pars. 12-14, 16-17, 63, and 74-75).

However, Stewart fails to disclose wherein the appropriate location module is capable of causing the mobile node to determine whether it is on an external network separated from the intranet by a corporate demilitarized zone.

Ahmed discloses wherein the location module is capable of causing the mobile node to determine whether it is on an external network separated from the intranet by a corporate demilitarized zone (col. 4 lines 4-29, 48-60, col. 6 line 56-col. 7 line 19).

Therefore, it would have been obvious to one of ordinary skill in the art at the time of the invention to modify the invention of Stewart, and have the location module capable of causing the mobile node to determine whether it is on an external network separated from the intranet by a corporate demilitarized zone as disclosed by Ahmed for the purpose of detecting position of the mobile devices for facilitating a possible

network handoff.

Regarding claims 3-6, 11-14, and 18-22, the combination of Stewart and Ahmed discloses the method, an article, and a mobile node according to claims 1, 9, and 17 further comprising deciding whether to retain the location module based on the dynamic information;

wherein deciding whether to retain the location module further comprises selecting an alternate location module if the dynamic information indicates the alternate location module is more suitable;

wherein applying the location module further comprises causing the mobile node to execute instructions in the location module;

wherein causing the mobile node to execute instructions in the location module further comprises causing the mobile node to register with an internal home agent and an external home agent;

wherein the processor is further capable of causing the policy module to select a first location module based on the static information in the configuration database, and wherein the processor is further capable of causing the policy engine to determine whether to retain the first location module (col. 10 lines 19-59, col. 13 lines 1-50, col. 14 lines 48-55, and col. 19 lines 1-47)

6. Claims 7, 15, and 23 are rejected under 35 U.S.C. 103(a) as being unpatentable over Stewart in view of Ahmed and further in view of U.S. Publication No.

2004/0037260 A1 to Kakemizu et al...

Regarding claims 7, 15, and 23, the combination of Stewart and Ahmed discloses the method according to claim 5, however, the combination fails to disclose wherein causing the mobile node to execute instructions in the location module further comprises examining a Dynamic Host Control Protocol ("DHCP") reply to determine a domain name.

Kakemizu et al. discloses wherein causing the mobile node to execute instructions in the location module further comprises examining a Dynamic Host Control Protocol ("DHCP") reply to determine a domain name (par. 122).

Therefore, it would have been obvious to one of ordinary skill in the art at the time of the invention to modify the combination, by causing the mobile node to execute instructions in the location module further comprises examining a Dynamic Host Control Protocol ("DHCP") reply to determine a domain name as disclosed by Kakemizu et al. for the purpose of having different addresses as mobile node roams on different network.

7. Claims 8, 16, and 24 are rejected under 35 U.S.C. 103(a) as being unpatentable over Stewart in view of Ahmed, and further in view of U. S. Publication No. 2006/0018296 A1 to Mukaoka et al..

Regarding claims 8, 16, and 24, the combination of Stewart and Ahmed discloses the method according to claim 5, however, the combination fails to disclose wherein causing the mobile node to execute instructions in the location module further

comprises causing the mobile node to compare its care of address ("COA") against a CIDR block address in a configuration database.

Mukaoka et al. discloses compare its care of address ("COA") against a CIDR block address in a configuration database (pars. 0125-128).

Therefore, it would have been obvious to one of ordinary skill in the art at the time of the invention to modify the combination, by comparing the address ("COA") against a CIDR block address in a configuration database as disclosed by Mukaoka et al. for the purpose of updating the database.
