Allowable Subject Matter and Reason for Allowance


4. Independent claim 1, and 11 are allowable over closest available prior art of Belau et al. (PG Pub. US 20020121810) because this reference does not make obvious to one of ordinary skill in the art to suggest a drive circuit for a firing cap, trigger-able by an electric direct-current firing pulse, of a vehicle restraint system, wherein a power switching element is inserted in the control path of the high-side switch and the control path of the low-side switch, causing the power switching element to draw lost power from the firing circuit during firing pulses.
5. Claims 1-10, and 12-18 are allowable because they are dependent on allowed claims 1, and 11.
