DETAILED ACTION

In view of applicant's amendment received August 8, 2005, amendments to the specification, claims and drawings have been entered. In a telephonic communication with applicant's representative Alfred J. Mangels on February 23, 2006, the examiner indicated that cancellation of claim 14 would place the application in condition for allowance. However, applicant would like further prosecution of claim 14. Therefore, an examination of pending claims 1, 3-9, and 11-14 is herein presented.

Drawings

The drawings are objected to because on page 3/3 of the replacement drawing, the lead line is missing for numeral 62. Corrected drawing sheets in compliance with 37 CFR 1.121(d) are required in reply to the Office action to avoid abandonment of the application. Any amended replacement drawing sheet should include all of the figures appearing on the immediate prior version of the sheet, even if only one figure is being amended. The figure or figure number of an amended drawing should not be labeled as "amended." If a drawing figure is to be canceled, the appropriate figure must be removed from the replacement sheet, and where necessary, the remaining figures must be renumbered and appropriate changes made to the brief description of the several views of the drawings for consistency. Additional replacement sheets may be necessary to show the renumbering of the remaining figures. Each drawing sheet submitted after the filing date of an application must be labeled in the top margin as either "Replacement Sheet" or "New Sheet" pursuant to 37 CFR 1.121(d). If the changes are

not accepted by the examiner, the applicant will be notified and informed of any required corrective action in the next Office action. The objection to the drawings will not be held in abeyance.

Claim Rejections - 35 USC § 102

The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

Claim 14 is rejected under 35 U.S.C. 102(b) as being clearly anticipated by US Patent 4,936,061 to Palma.

Claim 14:

Palma discloses a gutter end cap (Figure 1) for closing an end of a gutter that includes a gutter trough and a gutter cover (24) that overlies and blocks entry into the gutter trough (11), the end cap comprising a first gutter-trough closure region for blocking a gutter trough end (lower portion of end cap) and a second closure region positioned above the first closure region (upper portion of end cap) for blocking entry of debris into the gutter between the gutter trough and the overlying gutter cover.

Allowable Subject Matter

Claims 1, 3-9, and 11-13 are allowed.
