Continuation of Substance of Interview including description of the general nature of what was discussed: The Examiner asserted that Alles discloses all the limitations of claims 1-12 (col. 28, lines 31-54; Fig. 20 and 21; col. 8, lines 10-31). The Applicant agreed Alles was relevant and agreed to the changes illustrated in the separately submitted Examiner's Amendment to differentiate the claims from Alles. Alles discloses using a PDA to control a HVAC controller, but does not disclose the Applicant's method being implemented/integrated into the HVAC controller.
