DETAILED ACTION

Allowable Subject Matter

Claims 1 – 8 are allowed.

The following is an examiner's statement of reasons for allowance: Claim 1 recites a semiconductor laser driving apparatus structure including the specific structure limitation of first and second semiconductor laser, first and second driving means, a *second semiconductor laser thermally coupled with said first semiconductor laser; and a second semiconductor laser thermally coupled with said first semiconductor laser; and second driving means for driving said second semiconductor laser by a second drive current obtained by subtracting a current corresponding to the modulation signal for modulating the output laser beam of said second semiconductor laser from a current having a correlation with said first drive current*, which is neither anticipated or disclosed nor suggested in any piece of available prior art, which is neither anticipated nor obvious over the prior art of record.


