### **DETAILED ACTION**

### Continued Examination Under 37 CFR 1.114

1. A request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e), was filed in this application after final rejection. Since this application is eligible for continued examination under 37 CFR 1.114, and the fee set forth in 37 CFR 1.17(e) has been timely paid, the finality of the previous Office action has been withdrawn pursuant to 37 CFR 1.114. Applicant's submission filed on 5/30/06 has been entered.

## Claim Rejections - 35 USC § 102

1. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless -

- (b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.
- 2. Claims 1-5 and 7-9 are rejected under 35 U.S.C. 102(b) as being anticipated by Lannon (US 2,613,952 A).

Lannon discloses a transport comprising a case B with a zipper opening in the lower region (if secured upside down) and a handle or hand grip 4 in the upper region, and a transport device including horizontal and vertical plates 10, 14, and a strip or fastening means 28 for securing the case to the transport device, as shown in figures 5-9.

With respect to claims 4 and 5, the tent is an intended purpose for the transport and therefore little patentable weight has been given to the tent structure, such as feet, rods, and posts, however, if a tent were stored in the case of Taube et al. it would inherently be above the transport device.

With respect to claim 8, the hook and loop fasteners are intended use and the case of Lannon is capable of being closed by hook and loop fasteners.

### Claim Rejections - 35 USC § 103

- 3. The following is a quotation of 35 U.S.C. 103(a) which forms the basis for all obviousness rejections set forth in this Office action:
  - (a) A patent may not be obtained though the invention is not identically disclosed or described as set forth in section 102 of this title, if the differences between the subject matter sought to be patented and the prior art are such that the subject matter as a whole would have been obvious at the time the invention was made to a person having ordinary skill in the art to which said subject matter pertains. Patentability shall not be negatived by the manner in which the invention was made.
- 4. Claims 6, 7, 10, and 11 are rejected under 35 U.S.C. 103(a) as being unpatentable over Lannon, as applied to claim 1 above.

Lannon discloses a chamber with cover (not numbered) able to store wheels, as shown in figure 1A. Lannon does not disclose multiple wheels as being detachable. Simply adding extra wheels and/or making wheels removable is not patentable unless it produces an unexpected result, and therefore it would have been obvious to one having ordinary skill in the art at the time of the invention to have provided the transport of Lannon with the detachable wheels.
