

LETTER REGARDING PATENT TERM ADJUSTMENT

Dear Sir:

The Patent Term Adjustment listed on the Patent issued March 9, 2010 indicates a patent term extension of 1212 days. Patentees submit that the 1212-day patent term extension is thought to be longer than appropriate.

In particular, the patent term extension appears to have been calculated without consideration to Patentees' *Notice of Appeal* filed on January 7, 2008 and Patentees' *Request for Continued Examination* filed on April 7, 2008. Patentees believe that the patent term extension should therefore be **1060 days**.
