Continuation of 11. does NOT place the application in condition for allowance because: Applicant's argument regarding JP'642 is teaching of allylamine is not persuasive because allylamine as a co-polymer in JP'642 still reads on the claimed polyallylamine resin because the instant claims do not require the claimed polyallylamine resin to be homopolymer only. In addition, applicant's argument regarding JP'642's teaching of hydrolysable titanium compounds and hydrogen peroxide is not persuasive because JP'642 does teach using titanium compound comprising complex fluoride(paragraph [0057]). Furthermore, applicant's argument regarding co-precipitate of polyallylamine and Zr O₂ is not convincing because the co-precipitate is not recited in any of the claims, therefore, is not within the scope of the claimed invention.
