The undersigned representative thanks the Examiners for the courtesy of the in-person interview held on March 20, 2006.


The interview included a discussion of claims 1-33 and the 35 U.S.C. § 102(e) rejection of record. During the interview, the Examiners agreed that Applicant's amendments to independent claims 1, 19, and 31, made in response to the Office action of December 15, 2005, appear to overcome the 35 U.S.C. § 102(e) rejection of record. Both parties came to the agreement that, based on the amended claims made in the response to the Office action of December 15, 2005, "electronic media" comes from the source. The Examiners indicated that claims 19 and 31 will be reviewed for possible 35 U.S.C. § 101 issues, but any rejections made under 35 U.S.C. § 101 will be non-final. Applicant further notes that the undersigned representative's registration number was incorrect in the response to the Office action of December 15, 2005, and the correct number is 50,620.
