

DETAILED ACTION

1. Claims 1-18 are presented for examination.

REASONS FOR ALLOWANCE

2. The following is an examiner's statement of reasons for allowance: the prior art of record does not teach or discuss a method, system, device or computer-executable instructions for causing a telecommunications device such as a mobile device to determine first checksum values relating to a first data transmission event and second checksum values relating to a second transmission event which derive or describe the contents of physical memory components of a first and a second electronic device with a transmission from the first electronic device to the second electronic device being an initialization message having either the first checksum value and the second checksum value or information for determining the first checksum value and the second checksum value and using a comparison of the first checksum values and the second checksum values for causing the contents of the physical memory components to correspond to each other when the first checksum values or the second checksum values do not correspond to each other.

3. Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."


