generating a request for online third-party-provided information about the [[a]] second document associated with the hyperlink, wherein the third-party-provided information comprises a content snippet of the second document [[and is]] provided by a source other than a publisher or author of the second document, and wherein the content snippet comprises a portion of text found in the second document;

receiving the third-party-provided information; and

causing the third-party-provided information to be output in association with the first document.

- 2. (Original) The method of claim 1, further comprising logging the interest signal.
- 3. (Original) The method of claim 1, wherein the third-party-provided information comprises user-related information.
- 4. (Original) The method of claim 3, wherein the user-related information comprises query-related information.

- 14. (Original) The method of claim 1, wherein the third-party-provided information comprises a query corresponding to the second document.
- 15. (Currently Amended) The method of claim 1, wherein the third-party-provided information comprises a comparison between content from the first document associated with the hyperlink and content from the second document.
- 16. (Original) The method of claim 1, wherein the third-party-provided information comprises a cached representation of a previously-available second document.
- 17. (Original) The method of claim 1, wherein the interest signal comprises an indication of a pointing device hovering over the hyperlink.
- 18. (Original) The method of claim 1, wherein the interest signal comprises an indication of a right-click of a pointing device on the hyperlink.
- 19. (Original) The method of claim 1, wherein output in association with the first document comprises displaying the third-party-provided information in an overlay.
- 20. (Original) The method of claim 19, wherein the overlay comprises a tooltip.

- 21. (Original) The method of claim 1, wherein output in association with the first document comprises displaying the third-party-provided information in a status bar.
- 22. (Original) The method of claim 1, wherein output in association with the first document comprises displaying the third-party-provided information in a right-click menu.
- 23. (Original) The method of claim 1, wherein output in association with the first document comprises displaying the third-party-provided information in a pop-up window.
- 24. (Original) The method of claim 1, wherein output in association with the first document comprises displaying the third-party-provided information in a persistent window.
- 25. (Original) The method of claim 1, wherein output in association with the first document comprises displaying the third-party-provided information with the first document.
- 26. (Original) The method of claim 1, wherein output in association with the first document comprises audibly outputting the third-party-provided information.
- 27. (Original) The method of claim 1, wherein output in association with the first document comprises outputting the third-party-provided information through a haptic device.

28. (Currently Amended) The method of claim 1, wherein output in association with the first document comprises outputting a hyperlink associated with referencing a third document, the third document comprising the third-party-provided information.

29. (Currently Amended) A method comprising:

information to be output in association with the first document.
