As to claims 14-16, the prior arts do not disclose or suggest a channel for an integrated circuit tester comprising: comparator means linked to the I/O port for producing an indicating signal indicating whether a voltage at the I/O port exceeds an adjustable reference voltage supplied; and control means for supplying the first, second and third control signals and the adjustable reference voltage to the first and second transistors, the reference signal generation means and comparator respectively; in combination with the other claimed elements.
