Claims 1-3 and 6 have been cancelled.

#### ***Reasons for Allowance***

2. The following is an examiner's statement of reasons for allowance: Rejected claims 10 and 13-16 have been cancelled. In regard to claims 4,5,7,11,12,17 and 24, the prior art of record when considered as a whole, alone or in combination, neither anticipates nor renders obvious a first refrigeration module having a vapor compression circuit or hermetic compressor assembly within opposite heat exchanger surfaces and a second module has one attachment feature of the first and second modules are secured together and the first surface of one of the first and second modules is in thermal communication with the second surface of the other of the first and second modules or connected in series.
