Continuation of 3. NOTE: The rejections of claims 7 and 12-15 under 35 USC 112 second paragraph made in the final rejection mailed on December 31, 2007 are not overcome. The Examiner suggests rearranging the language of claim 7, for e.g. insertion of "wherein the means of imparting torque comprises a driver and the means for guiding comprises a targeting guide having at least one guide hole for guiding the elongated member to a desired location on the bone" immediately after "second end; and" (line 8 of the version of claims submitted on October 9, 2007) to overcome the rejection.
