Continuation of 13. Other: Review of Applicant's After-Final submission, made up solely of arguments, the arguments do not establish clear evidence of allowability as required by the MPEP.

The MPEP generally discourages the reopening of prosecution once prosecution is closed through the issuance of a final rejection. The MPEP has a relatively high bar for an examiner's withdrawal of the finality of prosecution once it is closed through a final rejection, limiting such reopening of prosecution to clear evidence of allowability if such evidence were to come to the examiner in a timely manner upon the issuance of a final rejection, or in the case of the recognition of a serious legal error made in the final rejection. These guidelines are explained by MPEP 706.07(e) Withdrawal of Final Rejection, General. "See MPEP § 714.12 and § 714.13 for amendments after final rejection. Although it is permissible to withdraw a final rejection for the purpose of entering a new ground of rejection, this practice is to be limited to situations where a new reference either fully meets at least one claim or meets it except for differences which are shown to be completely obvious".
