- 32. (Original) The toy of Claim 31, wherein said sound module is adhered to said bore.
- 33. (Original) The toy of Claim 31, wherein said sound module is heat bonded to said bore.

[[The]] A pet chew toy[[of Claim 15 further]] comprising:

an elongated body member having a plurality of ribs and a corresponding plurality of interstitial spaces formed therebetween, [[impregnating]] said body member impregnated with a liquid flavoring, said liquid flavoring dispensed through a plurality of apertures formed in said body member, said plurality of ribs and said plurality of interstitial spaces capable of cooperatively impinging at least one consumable treat;

wherein said plurality of ribs comprise:

a first series of ribs and a first series of interstitial spaces therebetween helically

disposed about a central axis of [[said]] a first bore; and

a second series of ribs and a second series of interstitial spaces therebetween helically

disposed about a central axis of [[said]] a second bore;

said first bore parallelly disposed to said second bore.

35. (Currently Amended) [[The]] A pet chew toy[[of Claim 15 further]] comprising:

an elongated body member having a plurality of ribs and a corresponding plurality of

interstitial spaces formed therebetween, [[further comprising impregnating]] said body member

impregnated with a scented aroma, said plurality of ribs and said plurality of interstitial spaces

capable of cooperatively impinging at least one consumable treat;

wherein said plurality of ribs comprise:

a first series of ribs and a first series of interstitial spaces therebetween helically

a second series of ribs and a second series of interstitial spaces therebetween helically

disposed about a central axis of [[said]] a second bore;

said first bore parallelly disposed to said second bore.

36. (Currently Amended) [[The]] A pet chew toy [[of Claim 15]] comprising:

an elongated body member having a plurality of ribs and a corresponding plurality of interstitial spaces formed therebetween, said plurality of ribs and said plurality of interstitial spaces capable of cooperatively impinging at least one consumable treat:

wherein said plurality of ribs comprise:

a first series of ribs and a first series of interstitial spaces therebetween helically

disposed about a central axis of a first bore; and

a second series of ribs and a second series of interstitial spaces therebetween helically disposed about a central axis of a second bore;

said first bore parallelly disposed to said second bore;

wherein said toy is formed by extrusion molding.

- 37. (Original) The toy of Claim 36, wherein said toy is formed from thermoplastic.
- 38. (Currently Amended) [[The]] A pet chew toy [[of Claim 15]] comprising:

 an elongated body member having a plurality of ribs and a corresponding plurality of

interstitial spaces formed therebetween, said plurality of ribs and said plurality of interstitial spaces capable of cooperatively impinging at least one consumable treat;

wherein said plurality of ribs comprise:

a first series of ribs and a first series of interstitial spaces therebetween helically

disposed about a central axis of a first bore; and

a second series of ribs and a second series of interstitial spaces therebetween helically disposed about a central axis of a second bore;

said first bore parallelly disposed to said second bore;

wherein at least one of said bores is enclosed by a threaded cap.

- 39. (Original) The toy of Claim 38, wherein at least one of said bores is enclosed by a first threaded cap at an end and by a second threaded cap at an opposite end.
- 40. (Original) The toy of Claim 38, wherein at least one of said bores is enclosed by a bond molded cap.
- 41. (Original) The toy of Claim 38, wherein at least one of said bores is enclosed by a first bond molded cap at an end and by a second bond molded cap at an opposite end.
- 42. (Original) The toy of Claim 38, wherein at least one of said bores houses a sound module, said sound module generating a prerecorded sound upon activation.

- 43. (Original) The toy of Claim 42, wherein said sound module is adhered to said bore.
- 44. (Original) The toy of Claim 42, wherein said sound module is heat bonded to said bore.
- 45. (Currently Amended) The toy of Claim [[16]] <u>17</u> further comprising impregnating said body member with a liquid flavoring, said liquid flavoring dispensed through a plurality of apertures formed in said body member.
- 46. (Currently Amended) The toy of Claim [[16]] <u>17</u> further comprising impregnating said body member with a scented aroma.
- 47. (Currently Amended) The toy of Claim [[16]] <u>17</u>, wherein said toy is formed by extrusion molding.
- 48. (Original) The toy of Claim 47, wherein said toy is formed from thermoplastic.
- 49. (Currently Amended) The toy of Claim [[16]] <u>17</u>, wherein at least one of said bores is enclosed by a threaded cap.
- 50. (Original) The toy of Claim 49, wherein at least one of said bores is enclosed by a

first threaded cap at an end and by a second threaded cap at an opposite end.

- 51. (Original) The toy of Claim 49, wherein at least one of said bores is enclosed by a bond molded cap.
- 52. (Original) The toy of Claim 49, wherein at least one of said bores is enclosed by a first bond molded cap at an end and by a second bond molded cap at an opposite end.
- 53. (Original) The toy of Claim 49, wherein at least one of said bores houses a sound module, said sound module generating a prerecorded sound upon activation.
- 54. (Original) The toy of Claim 53, wherein said sound module is adhered to said bore.
- 55. (Original) The toy of Claim 53, wherein said sound module is heat bonded to said bore.
- 56. (Currently Amended) The toy of Claim [[16]] 17, wherein each one of said plurality of ribs is substantially disposed in a direction parallel to said first bore and said second bore.
- 57. (Currently Amended) The toy of Claim [[16]] <u>17</u>, wherein each one of said plurality of ribs is substantially helical to said first bore and said second bore.
