DETAILED ACTION

This action is responsive to Applicant's communication filed 03/13/2008.

Claim 45 has been added as new.

Claims 1-3, 9-28, 30, 31, 33 and 35-45 are pending.

Newly submitted claim 45 is directed to an invention that is independent or distinct from the invention originally claimed for the following reasons: the newly submitted claim 45 is directed towards luminous means for irradiating white light emitting light with different wavelengths.

Since applicant has received an action on the merits for the originally presented invention, this invention has been constructively elected by original presentation for prosecution on the merits. Accordingly, claim 45 is withdrawn from consideration as being directed to a non-elected invention. See 37 CFR 1.142(b) and MPEP § 821.03.

Allowable Subject Matter

Claims 1-3, 9-28, 30-31, 33, 35-44 are allowed.

As indicated in the Office Action dated 10/04/2007, the prior art of record teaches all the fails to teach or fairly suggest a diagnostic imaging apparatus comprising luminous means held between one's fingers comprising a storage box, wherein said image storage means is provided with an automatic photography control means for executing a predetermined time sequence by manual operation of a photography switch each time irradiation light with a different wavelength is selectively irradiate.
