a control means for recording and storing the predetermined diagnostic image information formed by said means for imaging, as a static image; and

~~or a foot pedal so as to record and store the diagnostic image information formed by said imaging means as a static image; and~~

automatic photography control means for executing a predetermined time sequence by manual operation of a photography switch, provided with said image storing means, to sequentially store and keep in a memory the predetermined diagnostic image information formed by said imaging means each time irradiation light with a different wavelength is selectively irradiated.
