DETAILED ACTION

The finality has been withdrawn.

Claim Rejections - 35 USC § 112

The following is a quotation of the second paragraph of 35 U.S.C. 112:

The specification shall conclude with one or more claims particularly pointing out and distinctly claiming the subject matter which the applicant regards as his invention.

Claims 2-16 and 18-21 are rejected under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention. Correction and/or clarification is required.

Regarding claims 2, 7, 9 and 21, the recitation “means for balancing the first transistor and the second transistor” is indefinite because it is not clear what it is. As understood by the examiner, the feedback wire connected from the source of the third transistor (24) to the source of the second transistor (18) is the “means for balancing the first transistor and the second transistor”. It is not clear as to the “means for balancing the first transistor and the second transistor” is the feedback wire or another separate means. Clear explanation is required.

Regarding claims 10, 18 the recitation “means for feeding back” is indefinite because it is not clear what it is in the drawing.

Claims 3-6, 8, 11-16, 19 and 20 are indefinite because of the technical deficiencies of claims 2, 7, 10 and 18.

Allowable Subject Matter

Claims 2-16 and 18-21 would be allowable if rewritten or amended to overcome the rejection(s) under 35 U.S.C. 112, 2nd paragraph, set forth in this Office action.

Claims 2-16 and 18-21 would be allowable because the prior art of records fails to teach or suggest a buffer circuit comprising a third transistor having the source coupled to the source of the second transistor and the gate coupled to the drain of first transistor as called for in claims 2, 7, 9, 10 and 21; three transistors, feedback means, first and second current sources as called for in claim 18.
