The Examiner has objected to the recitation of a value "370 days" in Specification paragraphs [0038] and [0113], which refer to Figure 4, on grounds that the value recited is not supported by the application Specification.

Claims 16 - 18, 20 - 21, 23 - 24, 28 - 29, and 31 - 32 are rejected under 35 U.S.C. § 112, first paragraph, as failing to comply with the written description requirement for a variety of different reasons.

Claims 16 - 28, 20 - 21, 23 - 24, 28 - 29, and 31 - 32 are rejected under 35 U.S.C. § 102(e) as being anticipated by Montgomery et al. U.S. Patent No. 6,605,394.
