- 15. (Currently Amended) A telecommunications system, comprising:
- a voice message storage and retrieval unit;
- a Caller ID data recording unit configured to record Caller ID data from callers calling said system, the caller ID data including a calling party number;

an interface configured to transmit the recorded Caller ID data to a remote location when the recorded messages are retrieved; and

a call control system local to a caller calling the system and configured to receive the transmitted Caller ID data:

wherein said call control system includes a Caller ID storage and retrieval unit configured to cause [[a]] the transmitted calling party number corresponding to included in the received Caller ID data to be called by said call control system.

- 16. (Previously Presented) A system in accordance with claim 15 wherein said call control system is a PBX.
- 17. (Previously Presented) A system in accordance with claim 15 wherein said call control system is a telephony-over-LAN (ToL) gatekeeper.
