### **Allowance**

1. Claims 15-19 and 21-26 are allowed.

### **Reasons for Allowance**

2. First off, the instant claims require two call control systems. To be sure, according to Figure 2 of the filed drawings, Central Office 2 represents the first call control system<sup>1</sup> while Central Office 3 represents the second call control system. The remarks filed on 3/23/2009 shed further light on the meaning of what a control system is. According to page 9 of those remarks:

**In telephony, call control refers to the software within a telephone switch that supplies its central function. Call control decodes addressing information and routes telephone calls from one end point to another (emphasis in original).**

With respect to Goldman et al, European Patent Publication No. 0,588,101 (hereinafter Goldman), Goldman discloses a Caller ID data recording unit (see unit 46 from Figure 6), a remote location (see unit 80 from Figure 6) and a call control system (see unit 102 from Figure 6) that includes a Caller ID storage and retrieval unit configured to cause the transmitted calling party number included in the received Caller ID data to be called by the call control system. However, Goldman does not

disclose another call control system that is separate from the call control system that performs the claimed calling function, wherein the Caller ID data recording unit is associated with the other call control system. For this reason, claims 15, 21 and 26 are allowed.
