Continuation of 11. does NOT place the application in condition for allowance because: It is first noted that the amendment after final was entered to correct minor informalities. Applicant asserts that Pianciola does not teach tapering of each optical fiber. However, in the final rejection mailed June 5, 2006, the Examiner pointed to two sections (claim 1; column 3, lines 59-66) in which tapering of both fibers is disclosed. As such, the final rejection mailed June 5, 2006 meets all requirements of 35 U.S.C. 103(a).
