DETAILED ACTION

Claims 28-29, 32-41, 44-52, and 55-60 are pending in the current application.

Double Patenting

1. The nonstatutory double patenting rejection is based on a judicially created doctrine grounded in public policy (a policy reflected in the statute) so as to prevent the unjustified or improper timewise extension of the “right to exclude” granted by a patent and to prevent possible harassment by multiple assignees. A nonstatutory obviousness-type double patenting rejection is appropriate where the conflicting claims are not identical, but at least one examined application claim is not patentably distinct from the reference claim(s) because the examined application claim is either anticipated by, or would have been obvious over, the reference claim(s). See, e.g., *In re Berg*, 140 F.3d 1428, 46 USPQ2d 1226 (Fed. Cir. 1998); *In re Goodman*, 11 F.3d 1046, 29 USPQ2d 2010 (Fed. Cir. 1993); *In re Longi*, 759 F.2d 887, 225 USPQ 645 (Fed. Cir. 1985); *In re Van Ornum*, 686 F.2d 937, 214 USPQ 761 (CCPA 1982); *In re Vogel*, 422 F.2d 438, 164 USPQ 619 (CCPA 1970); and *In re Thorington*, 418 F.2d 528, 163 USPQ 644 (CCPA 1969).

A timely filed terminal disclaimer in compliance with 37 CFR 1.321(c) or 1.321(d) may be used to overcome an actual or provisional rejection based on a nonstatutory double patenting ground provided the conflicting application or patent either is shown to be commonly owned with this application, or claims an invention made as a result of activities undertaken within the scope of a joint research agreement.

Effective January 1, 1994, a registered attorney or agent of record may sign a terminal disclaimer. A terminal disclaimer signed by the assignee must fully comply with 37 CFR 3.73(b).

2. Claims 28-29, 32-41, 44-52, and 55-60 are rejected on the ground of nonstatutory obviousness-type double patenting as being unpatentable over claim claims 1, 4, 11, and 14, of U. S. Patent No. 7,437,556.

3. Although the conflicting claims are not identical, they are not patentably distinct from each other. The examiner can ascertain no difference between the claims of the

present application and that of U. S. Patent No. 7,437,556. It is noted that the minor difference encompass replacement of the recitation of the limitations in the claims and it appears to be substantially the same or duplicate or in some instance obvious over one another. For example, claims 28, 40, and 42 in establishing a non-global zone for isolating user processes, the functions performed by the steps are the same and obvious as the steps of claims 1, 4, 11, and 14 of U. S. Patent No. 7,437,556.

Claim Rejections - 35 USC § 101

4. 35 U.S.C. 101 reads as follows:

Whoever invents or discovers any new and useful process, machine, manufacture, or composition of matter, or any new and useful improvement thereof, may obtain a patent therefor, subject to the conditions and requirements of this title.

5. Claims 52-60 are rejected under 35 U.S.C. 101 because the claimed invention is directed to non-statutory subject matter.

6. Claim 52 recites "an apparatus" and invokes §112, 6th paragraph, by reciting means for establishing, within a global operating system environment provided by an operating system (OS) kernel, a first non-global zone. However, according to the specification, the means for establishing, within a global operating system environment provided by an operating system (OS) kernel, a first non-global zone appear to be software pro se and is functional descriptive material. However, function descriptive material is nonstatutory when claimed as descriptive material per se. When functional descriptive material is recorded on some computer-readable medium, it becomes structurally and functionally interrelated to the medium and will be statutory in most

cases since use of technology permits the function of the descriptive material to be realized. Since claim 52 does not recite the means for establishing as being recorded on a computer-readable medium, the apparatus is interpreted as comprising functional descriptive material per se and non statutory. See MPEP § 2106.01.

Allowable Subject Matter

- 7. Claims 28-29, 32-41, and 44-52 are allowed.**

- 8. Claims 52-60 would be allowable if rewritten or amended to overcome the rejection(s) under 35 U.S.C. 101, set forth in this Office action.**
