

NOTE:

The newly added limitations to claim 59, which call for "one or more heating devices", a group of alloys further consisting of "754, TD, 758, 602, 690, 276, 263, DS, 302, 803 and 864", an "oxygenate inlet" and an "oxygenate feed introduction nozzle", raise new issues, and thereby necessitate further search and/or consideration. In addition, the newly presented claims 104-108 are broader in scope than the previously presented claims, thereby necessitating further search and/or consideration.
