REASONS FOR ALLOWANCE

The following is an examiner's statement of reasons for allowance: the overall claimed combination of a wetting receptacle defining a wetting fluid receiving space, a urinary catheter having a hydrophilic outer surface on at least an insertable length and a wetting fluid container that is integrated with the wetting receptacle and has a discharge portion that is disposed within the wetting receptacle and in fluid communication with the wetting fluid receiving space has neither been anticipated nor rendered obvious by the prior art of record.

Likewise, the overall claimed combination of a wetting apparatus comprising a catheter package comprising a sealed elongate volume containing a urinary catheter wherein the sealed elongate volume has at least one chamber containing a wetting fluid container that is integrated with the elongate volume in a releasably secured manner in the inlet of the wetting receptacle wherein a forward portion of the wetting fluid container presents a discharge portion and a rearward portion of the wetting fluid container projects from the inlet has neither been anticipated nor rendered obvious by the prior art of record.


Further, the overall claimed combination of a wetting apparatus comprising a first chamber provided with an inlet that is adapted to receive at least a portion of a second chamber and a second chamber that is releasably secured to the inlet of the first chamber by insertion of a forward portion which presents a discharge portion having a discharge opening has neither been anticipated nor rendered obvious by the prior art of record.
