DETAILED ACTION

Allowable Subject Matter

Claims 1-10, 13-22, 25, 27 are allowed.

The following is an examiner's statement of reasons for allowance: The Applicant's invention is directed to isolating a process to zones. The Applicant arguments regarding the Ellison reference not having cross-zone boundary (i.e. a process that crosses zones) is persuasive.
