

### REASONS FOR ALLOWANCE

1. The following is an examiner's statement of reasons for allowance: prior art of record considered as a whole alone or in combination neither anticipates nor renders obvious, elastic biasing means for elastically biasing the stop member to a nonoperating position, and forced slide means for selective sliding the stop member to an operating position against an elastic biasing action the elastic biasing means, in combination with the rest of the limitations in claim 5.
