The following remarks below are respectfully submitted in response to the Office Action dated November 30, 2005. Applicants are filing a Petition for Extension of Time concurrently with this response.

REMARKS

The Examiner has rejected claims 1-33 provisionally under 35 U.S.C. § 101 as claiming the same invention as that of claims 1-33 of co-pending application No. 09/882,363. The Examiner also has raised issues under 35 U.S.C. § 102(g) and 35 U.S.C. § 102(f). Applicants respectfully traverse these rejections, because claims 1-33 of co-pending application No. 09/882,363 were cancelled some time ago, and are no longer pending in that application. Perhaps the Examiner was referring to the published version of Application No. 09/882,363. However, in the prosecution of that application, claims 1-33 were cancelled. Therefore, no such rejection is proper, and accordingly Applicants respectfully request that the Examiner reconsider
