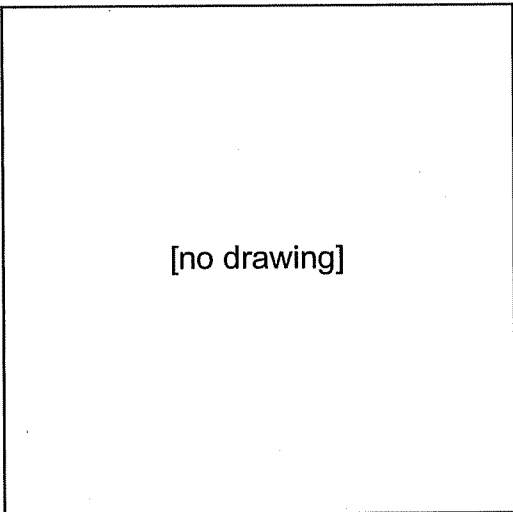

**Endoprothese fuer einen Hueftkopf
ORTHOPLANT ENDOPROTHETIK**

Abstract:

There is specified an endoprosthesis for a femoral head which possesses a prosthetic section for fixing in a corresponding recess in the human femoral head. The prosthetic section is designed as a strip-shaped runner whose outer surface is spherically bent in a manner corresponding to the femoral head, and forms a partial substitute for damaged osseous tissue.
