DETAILED ACTION

1. Applicant's Amendment filed 09/28/2004 has been reviewed and placed of record in the file.

Allowable Subject Matter

2. Claims 20 and 1-19 (to be renumbered 1-20) are allowable over the prior art of record.

The following is an examiner's statement of reasons for allowance: The prior art of record fails to teach or render obvious a method of fabricating a semiconductor latch for an integrated circuit having all exclusive limitations as recited in claims 1, 12, and 20, characterized in the step of forming two inverters cross-coupled to form a bi-stable latch, supplying each of the inverters with a first supply voltage and a second supply voltage of different potentials, and fabricating at least one of the inverters in a semiconductor thin film module, the module layers deposited substantially above a semiconductor layer module used to construct high performance switching logic circuits.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
