In accordance with the duty of disclosure under 37 C.F.R. Sections 1.56, 1.97, and 1.98, Applicants hereby submit the following documents for the Examiner's consideration:

Applicants submit herewith a copy of a European Search Report dated June 20, 2003 conducted in connection with European Patent Application No. 03 090 021.1-2313, which is a counterpart of the above-captioned application. In particular, the European Examiner cited:

- (1) U.S. Patent No. 4,889,138 issued to HEITMANN et al. December 26, 1989 as an "X" category document (i.e., a document that calls into question of the novelty or inventive step when considered alone). In particular, the European Examiner noted column 5, line5 - column 6, line 40; and Figure 1 as relevant to claims 1 - 6, 10, 11, and 14 - 16 of the European application;

(2) U.S. Patent No. 4,524,781 issued to SERAGNOLI June 25, 1985 as an "X" category document. In particular, the European Examiner noted column 3, lines 35 - 65; column 4, lines 19 - 23; and Figure 1 as pertinent to claims 1 - 5, 10, 11, 13, 19, and 20 of the European application;

(3) U.S. Patent No. 5,009,238 issued to HEITMANN April 23, 1991 as an "A" category document (i.e., technological background). The European Examiner noted the abstract and drawings as relevant to claims 1 and 10 of the European application; and

(4) U.S. Patent No. 4,607,645 issued to OKUMOTO et al. August 26, 1986 as an "A" category document. In particular, the European Examiner noted column 2, line 56 - column 4, line 8; and Figure 2 as pertinent to claims 1 - 22 of the European application.

Applicants further note that the following document is being submitted for consideration by the Examiner:

(5) German Patent Application No. 40 35 937 published May 29, 1991.


