Claims 1-2, 5-8, 10-14 and 17-20 are rejected under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention.

In particular, the applicant has amended these claims (or the claims upon which they depend) to include the phrase "geometric figure" and these new limitations are inappropriate. The examiner has read the foreign search report provided in the applicant's last response and realizes that applicant's amendments have probably resulted from the comments made in that report concerning the definition of the term "geometry", but believes that this change makes the problem worse, not better. First of all, this examiner did not reject the original claims because he felt that the term was sufficiently defined in the specification. Secondly, the new term "geometric figure" normally indicates a three-dimensional figure, such as a cone or some other spray pattern, and that is not what the applicant is referring to in his specification. In actuality, the applicant is talking about a simple two-dimensional curve that represents the fuel injection rate and the area of which represents the fuel quantity. Thus, the applicant should not have changed the claims in this manner and the claims that have not been changed and were indicated in the last office action as containing allowable subject matter have now been allowed.

The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

(e) the invention was described in (1) an application for patent, published under section 122(b), by another filed in the United States before the invention by the applicant for patent or (2) a patent granted on an application for patent by another filed in the United States before the invention by the

applicant for patent, except that an international application filed under the treaty defined in section 351(a) shall have the effects for purposes of this subsection of an application filed in the United States only if the international application designated the United States and was published under Article 21(2) of such treaty in the English language.

Claims 1-2, 5-8, 10, 13-14, and 17-20 are rejected under 35 U.S.C. 102(e) as being anticipated by Crofts ('533)

In particular, the applicant's attention is directed to Figure 4 and the description of this figure found in paragraphs [0036] and [0038] 1 of the disclosure.

The following is a quotation of 35 U.S.C. 103(a) which forms the basis for all obviousness rejections set forth in this Office action:

(a) A patent may not be obtained though the invention is not identically disclosed or described as set forth in section 102 of this title, if the differences between the subject matter sought to be patented and the prior art are such that the subject matter as a whole would have been obvious at the time the invention was made to a person having ordinary skill in the art to which said subject matter pertains. Patentability shall not be negated by the manner in which the invention was made.

Claims 11-12 are rejected under 35 U.S.C. 103(a) as being unpatentable over Crofts ('533).

Crofts applies as noted above and the noted paragraph [0036] notes that the delay times for each feedback cycle are noted and then used in the next injection cycle. In order to use these variations, it would have been obvious to store them as learned values (if not inherent).

Claims 3-4, 9 and 15-16 are allowed.

Applicant's arguments filed 1/11/07 have been fully considered but they are not persuasive. In particular, applicant's Claim 2 states that the lift sensor of this claimed device is used to at least approximate the fuel injection rate. This is also true in Crofts and this is clear from the disclosures found in paragraphs [0036] ad [0038] of the reference. While it may be true that the device initially uses other means to set the

injection timing and quantity, this is also true in the applicant's device and is clearly claimed in line 3-4 of Claim 1. Crofts then uses the feedback from the lift sensor to control timing, quantity and injection rate.
