The request for reconsideration has been considered but does NOT place the application in condition for allowance because: Per Applicant's argument of 35 USC 101 rejection, the term "computer-readable" signal-bearing medium can be interpreted as signal. Per Applicant's argument of 35 USC 112 rejection, Applicant recite various unrelated patents, the Applicant still does not provide a precise definition of "a legacy management system". Regarding Applicant's argument of 35 USC 102(b) rejection, the examiner considers Baughman's active and standby configuration is one type of currently sharing management responsibility. Regarding Applicant's argument that traffic loading is not a management responsibility, the examiner considers person skilled in the art would agree traffic loading is one type of management responsibility for network management.
