## **DETAILED ACTION**

### ***Response to Arguments***

1. Applicant's arguments, see pages 6-11, filed 01 June 2007, with respect to all claims have been fully considered and are persuasive. In view of the Applicant's amendments adding limitations to the claims, the previous rejection of pending claims has been withdrawn.

### ***Allowable Subject Matter***

2. Claims 1-4 and 6-15 are allowed over the Prior Art of record.
3. The following is an examiner's statement of reasons for allowance: The primary reasons for allowance of all independent claims (1, 6, 12 and 15) is the inclusion of the specific limitation of a *slipstream* (emphasis added) (i.e. a specific type of flow behind a body/element) for providing a sample of reformat to a sensor/transducer in a fuel cell or system for monitoring the performance of a hydrocarbon performer producing a reformat output. None of the Prior Art disclose or teach this specific limitation in combination with the other recited elements of the independent claims.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."


