Amdendment to independent claims 1, 25, 31, and 32 raises new issues that would require further consideration and/or search because the subject matter added to the claims further limits the claims. Namely, cancelling subject matter and then adding new features requires further consideration under USC 103. For instance, applicant removed the broad limitation "...a pattern of pits fomed in the bust cutting area is different from a pattern of pits formed in at least one of the lead -in area, the user data area and the lead-out area" while adding the narrowing limitation "...a pattern comprising a sequence of the pits is repeated in an area of the bu rst cutting area".
