The first "pRB" on the third line was deleted and --- the retinoblastoma gene product (pRB) --- was inserted.

--- the transcriptional factor --- was added before E2F-1 on third line.

2) The following is an examiner's statement of reasons for allowance:

The art does not teach or suggest the polypeptide SEQ ID NO:8, or a polypeptide having at least 90%, or 95% sequence identity with SEQ ID NO:8, wherein the polypeptide binds the tumor suppressor retinoblastoma gene product (pRB) and displaces the transcriptional factor E2F-1 bound to pRB. It is noted that: 1) E2F-1 when released from pRB mediates cell proliferation, and above a certain threshold, potentially apoptosis, and 2) deregulation of E2F-1 is found in the majority of human cancers (Seville et al, 2005, Current Cancer Drug Targets, 5: 159-170).
