The Applicant wishes to bring to the attention of the U.S. Patent and Trademark Office the information noted on the enclosed form(s) PTO/SB/08a & 08b, which may be considered material to the examination of the above-identified application.

This Information Disclosure Statement is submitted under 37 C.F.R. §1.97(c) after the C.F.R. §1.97(b) time period, but before the mailing date of final action, notice of allowance, or an action that otherwise closes prosecution in the application and is accompanied by the fee set forth in 37 C.F.R. §1.17(p)

This Information Disclosure Statement supplements the documents that Applicant submitted in previous Information Disclosure Statements, which were primarily connected with the case styled *Anascape, Ltd. v. Microsoft Corp., et al.* (the "Anascape Litigation") in the United States District Court for the Eastern District of Texas, Lufkin Division and assigned civil action number 9:06-CV-00158-RC. Following a May 2008 trial in the Anascape Litigation, defendant Nintendo of America, Inc. ("Nintendo") filed an appeal with the Court of Appeals for the Federal Circuit ("CAFC"), which appeal is designated *Anascape Ltd. v. Microsoft Corp. and Nintendo of America Inc.*, No. 2008-1500 at the CAFC. A new case, *Anascape, Ltd. v. Nintendo*, assigned civil action number 08-CV-00139, has been opened in the Eastern District of Texas in connection with the Nintendo appeal. Additional details regarding the May 2008 trial, including the jury's verdict and trial transcript excerpts, were provided in the Information Disclosure Statement dated June 26,

2008. Updated dockets are included herein for the Eastern District of Texas and CAFC as well as a brief filed by Nintendo with the CAFC.

The present Information Disclosure Statement further includes documents recently filed in related patent applications and in reexaminations of related issued United States Patents. The serial numbers of the related pending applications and reexaminations were identified in the Information Disclosure Statement dated June 26, 2008.
