## **REMARKS**

Claims 1-3, 5-25 and 27-40 are presently pending in the application. Of these, claims 1, 22, 23 and 30 are independent. Claim 26 has been cancelled without prejudice or disclaimer of the subject matter, and claims 23 and 27 are amended. Reconsideration of presently pending claims is respectfully requested in light of the above amendments and the following remarks.

### Claim 36 and New Claim 40

The claim listing included two claims numbered "Claim 36". In this amendment, the *second* "Claim 36" has been cancelled, and its subject matter is included as new "Claim 40".

## **Allowed and Allowable Claims**

Applicants acknowledge with appreciation the allowance of claims 1-3, 5-22 and 30-39. Claims 26-29 are objected to as being dependent upon a rejected base claim, but would be allowable if rewritten in independent form including all of the limitations of the base claim and any intervening claims. Accordingly, the limitations of claim 26 have been appended to independent claim 23, and claim 23 should now be in condition for allowance.

# Rejections under 35 U.S.C. § 102

Claims 23-25 were rejected under 35 U.S.C. §102(e) as being anticipated by WO 03/039400 to Huppert, et al. However, claim 23 is amended to include the features of allowable dependent claim 26 to more particularly define the invention, and claim 26 is cancelled. Therefore, claim 23 now includes all the limitations of allowable claim 26 and likewise should be in condition for allowance. Accordingly, Applicants respectfully request that the Examiner withdraw the rejection and allow claim 23.
