## **DETAILED ACTION**

### ***Election/Restrictions***

Applicant's election of invention 1 claims 1-3 in the reply filed on 12/13/06 is acknowledged. Because applicant did not distinctly and specifically point out the supposed errors in the restriction requirement, the election has been treated as an election without traverse (MPEP § 818.03(a)).

### ***Claim Objections***

Claim 1 is objected to because of the following informalities: in line 2 the claim states that "at last of portion of". The examiner believes that the applicant intended to recite "at least a portion of". Appropriate correction is required.

### ***Claim Rejections - 35 USC § 103***

The following is a quotation of 35 U.S.C. 103(a) which forms the basis for all obviousness rejections set forth in this Office action:

(a) A patent may not be obtained though the invention is not identically disclosed or described as set forth in section 102 of this title, if the differences between the subject matter sought to be patented and the prior art are such that the subject matter as a whole would have been obvious at the time the invention was made to a person having ordinary skill in the art to which said subject matter pertains. Patentability shall not be negated by the manner in which the invention was made.

Claims 1-3 are rejected under 35 U.S.C. 103 as being unpatentable over USPN 5,904,714 Nunez et al. in view of USPN 4,784,659 Fleckenstein.

Nunez discloses the invention substantially as claimed being an arterial prosthesis comprising woven layers of biologically inert polyester yarn and polyurethane

yarn. However, Nunez does not disclose that the layers are agglutinated with a gelatin/glycerin solution.

Fleckenstein teaches the use of a vessel prosthesis made of yarn, which is porous, but is sealed by impregnating with cross linked gelatin in the same field of endeavor for the purpose of sealing the prosthesis.

It would have been obvious to one having ordinary skill in the art at the time the invention was made to combine the gelatin agglutination taught by Fleckenstein with the woven prosthesis of Nunez in order to seal the prosthesis with a biocompatible solution.
