
As indicated, the cited document is in English and therefore, no statement of relevance is required. The foreign office action is in Chinese. A translation has been provided for the Examiner's convenience.

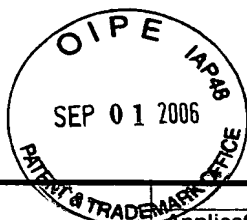
