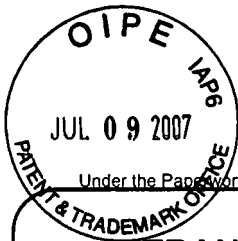

AMENDMENT UNDER 37 C.F.R. § 1.116 IN RESPONSE TO ACTION OF APRIL 6, 2007

This responds to the Office action mailed April 6, 2007. Please amend the present application as follows:
