## DETAILED ACTION

### *Claim Rejections - 35 USC § 102*

1. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

2. Claims 16-18 are rejected under 35 U.S.C. 102(b) as being anticipated by Toshima (US Patent NO 6,146,469).

Toshima teaches a method as claimed. The method comprises creating a needed pressure differential between the chamber for holding the liquid and generating a vapor and the processing chamber, by controlling the temperature of the holding chamber and by reducing the pressure of the processing chamber. The method further comprises supplying vapor with desired kinetic and thermal energy into processing chamber to clean an object. As to the gas-supplying step: Since the pressure of the processing chamber is reduced by evacuation the gas is supplied to this chamber at least at some point. Moreover, the limitation of the gas-supplying step is met by the gas flow at the time the valves 241 and 240 are opened and water is supplied to the chamber 120. See entire document, especially Figure 1 and the description at column 5, line 51 – column 8, line 18.

3. Claims 12-14 and 16-18 are rejected under 35 U.S.C. 102(b) as being anticipated by Kamikawa et al (US Patent No 5,940,985).

Kamikawa et al teach a method as claimed. See entire document especially Figures 7-9 and description at column 8, line 56 - column 13, line 57.

For this rejection claims 16-18 are interpreted as requiring pressurizing to a positive pressure.

### ***Double Patenting***

4. The nonstatutory double patenting rejection is based on a judicially created doctrine grounded in public policy (a policy reflected in the statute) so as to prevent the unjustified or improper timewise extension of the "right to exclude" granted by a patent and to prevent possible harassment by multiple assignees. A nonstatutory obviousness-type double patenting rejection is appropriate where the conflicting claims are not identical, but at least one examined application claim is not patentably distinct from the reference claim(s) because the examined application claim is either anticipated by, or would have been obvious over, the reference claim(s). See, e.g., *In re Berg*, 140 F.3d 1428, 46 USPQ2d 1226 (Fed. Cir. 1998); *In re Goodman*, 11 F.3d 1046, 29 USPQ2d 2010 (Fed. Cir. 1993); *In re Longi*, 759 F.2d 887, 225 USPQ 645 (Fed. Cir. 1985); *In re Van Ornum*, 686 F.2d 937, 214 USPQ 761 (CCPA 1982); *In re Vogel*, 422 F.2d 438, 164 USPQ 619 (CCPA 1970); and *In re Thorington*, 418 F.2d 528, 163 USPQ 644 (CCPA 1969).

A timely filed terminal disclaimer in compliance with 37 CFR 1.321(c) or 1.321(d) may be used to overcome an actual or provisional rejection based on a nonstatutory double patenting ground provided the conflicting application or patent either is shown to be commonly owned with this application, or claims an invention made as a result of activities undertaken within the scope of a joint research agreement.

Effective January 1, 1994, a registered attorney or agent of record may sign a terminal disclaimer. A terminal disclaimer signed by the assignee must fully comply with 37 CFR 3.73(b).

5. Claims 16-18 are provisionally rejected on the ground of nonstatutory obviousness-type double patenting as being unpatentable over claim 1 of copending Application No. 10/957,003. Although the conflicting claims are not identical, they are not patentably distinct from each other because the scope of the claims of the instant application is inside of the scope of the claim of the co-pending application and because

it is inherent that the pressure of the vapor must be higher than the pressure in the processing chamber to enable supplying.

This is a provisional obviousness-type double patenting rejection because the conflicting claims have not in fact been patented.

### ***Response to Arguments***

6. Applicant's arguments with respect to claims 16-18 filed 12/26/07 have been fully considered but they are not persuasive. The applicants amended claims and argue that the rejection over Toshima is not proper. The applicants allege that Toshima does not teach pressurizing step. The examiner disagrees. The claims do not recite to which pressure the container is pressurized. Thereby the teaching of Toshima anticipates the claims.

The applicants also argue that the double patenting rejection of these claims is not proper. The examiner disagrees because the scope of the claims of the instant application is inside of the scope of the claim of the co-pending application and because it is inherent that the pressure of the vapor must be higher than the pressure in the processing chamber to enable supplying. It is again noted that the claims do not recite to which pressure the container is pressurized.

7. Applicant's arguments with respect to claims 12-14 have been considered but are moot in view of the new ground(s) of rejection.

***Conclusion***

8. The prior art made of record and not relied upon is considered pertinent to applicant's disclosure. US Patents 6,350,322 and 4,977,688 are cited to show the state of the prior art with respect to processing wafers with gasses and vapors..
