DETAILED ACTION

1. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

2. Claims 1-5 are rejected under 35 U.S.C. 102(b) as being clearly anticipated by Hoedl 5,075,057 and Sullivan et al 5,565,158.

The '057 discloses a process for the manufacture of molded composite products from scrap wherein a plastic such as recycled PET is blended with other additives to prepare a composite capable of being further processed. The process comprises shredding the plastics to a fine particle size of free-flowing particles which are mixed or blended with other additives for further processing. Characteristics not expressly disclosed, such as the claimed particle size would appear to be inherent in view of the other characteristics disclosed of the particles.

The '158 discloses a process for recycling multi-component mixed polymer wastes which includes PET. The waste material is blended with other additives or polymers and further processed. See Example 1 in column 10.


