DETAILED ACTION

1. The text of those sections of Title 35, U.S. Code not included in this action can be found in a prior Office action.

2. Applicant's arguments filed 06/12/06 have been fully considered but they are not persuasive. See the explanations below.

3. Claims 1-5 are rejected under 35 U.S.C. 102(b) as being clearly anticipated by Hoedl '057 and Sullivan '158.

Both of the cited prior arts are of record in the previous communication, and their disclosures are as explained therein. Applicant takes the position that the '057 does not disclose the claimed particle size nor the mixing with a specialty additive as claimed. It is the Examiner's position that Applicant's argument is not convincing to overcome the rejection because, as indicated in the previous communication, the claimed particle size would be inherent in the prior art disclosed particle size below 1mm. Also, the scrap does contain PET, and it is mixed with a specialty additive as claimed. See column 3, lines 1-38; line 52 through column 4, line 51

Regarding the '158, see column 6, lines 1-27, and lines 55-64. It is the Examiner's position that the cited prior arts have features and characteristics as claimed.


