DETAILED ACTION

1. The Office has withdrawn all objections and rejections set forth in the Final Rejection mailed 2/7/08.

Information Disclosure Statement

2. The information disclosure statement filed 2/4/2011 fails to comply with 37 CFR 1.98(a)(2), which requires a legible copy of each cited foreign patent document; each non-patent literature publication or that portion which caused it to be listed; and all other information or that portion which caused it to be listed. It has been placed in the application file, but the information referred to therein has not been considered. Copies of cited non-patent literature documents (Non-Patent Literature Documents cited as documents #1, 2 and 88) were not included with the information disclosure statement (or in the parent application), and therefore not considered.

Reasons For Allowance

3. The cited references do not disclose an application calling a contact data control to request a first user interface and a second user interface, the contact data control being external to the application, a centralized data store that stores all contact data for the plurality of applications according to a single schema for which the application receiving the first user interface request to access contact data lacks the configuration to natively access, retrieving requested contact data and translating that contact data from a schematized format to the non-

schematized format, and further requesting that external contact data provide the application with authorization to access the schematized contact data, wherein the application natively lacks both the configuration and authorization to access the schematized contact data, and causing a display device to display the contact data at the second user interface to a user of the application, the displayed contact data corresponding to the contact data received by the application in a non-schematized format and converted by the external contact data control from the schematized format, and the contact data being displayed notwithstanding that the application lacks the configuration to natively access the contact data stored in the data store according to the schema.

4. After a thorough search, and in light of the prior art of record, claims 1, 4-15, 18, 21 and 28-36 (renumbered as 1- 1-24) are allowed.

5. Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled “Comments on Statement of Reasons for Allowance.”
