### Amendment to the Claims

Below is a complete listing of the claims.

- 1. (Withdrawn) A weapon for use by an operator, the weapon comprising:
  - a. apparatus that provides lethal force, non-lethal force, and illumination;
  - b. a first trigger operable with a first hand of the operator for releasing the lethal force; and
- c. a switch and a second trigger, the switch operable with a second hand of the operator when the second hand is in a position to operate the second trigger, the second trigger for releasing the non-lethal force; wherein
  - d. the illumination is controlled in response to operation of the switch.
- 2. (Withdrawn) The weapon of claim 1 wherein the illumination is for aiming the non-lethal force.
- 3. (Withdrawn) The weapon of claim 1 wherein the non-lethal force comprises electromuscular stimulation.
- 4. (Withdrawn) A weapon comprising:
  - a. apparatus that provides lethal force and non-lethal force;
  - b. a circuit comprising a switch and a source of illumination, wherein:

the circuit controls illumination from the source for aiming the non-lethal force;

and

the circuit controls release of the non-lethal force in response to operation of the switch.

- 5. (Withdrawn) The weapon of claim 1 wherein the non-lethal force comprises electromuscular stimulation.
- 6. (Currently amended) A support for attaching an <u>non-lethal</u> implement to a firearm, the firearm having a rail and a stop, the support comprising:
  - a. means for mechanically coupling the non-lethal implement to the rail; and
- b. means for coupling the <u>non-lethal</u> implement to the stop to reduce motion of the <u>non-lethal</u> implement along the rail parallel to a direction of delivery of the lethal force.
- 7. (Previously presented) The support of claim 6 wherein the rail conforms to a picatinny rail.
- 8. (Previously presented) The support of claim 6 wherein the stop comprises a sight.

- 9. (Previously presented) A support for attaching a non-lethal implement to a firearm, the firearm having a rail and a stop, the support comprising:
- a. a first channel that receives the rail to mechanically couple the non-lethal implement and the rail;
  - b. a first abutment surface that abuts the stop;
  - c. a first fastener that maintains the first abutment surface against the stop;
  - d. a second channel that receives the non-lethal implement; and
  - e. a second fastener that retains the non-lethal implement in the second channel.
- 10. (Previously presented) The weapon of claim 9 wherein the implement delivers a non-lethal force comprising electromuscular stimulation.
- 11. (Previously presented) The support of claim 9 wherein the rail conforms to a picatinny rail.
- 12. (Previously presented) The support of claim 9 wherein at least one of the first fastener and the second fastener is manually releasable without a tool.
- 13. (Previously presented) The support of claim 12 wherein the at least one fastener is released by manually accomplishing a rotary motion of a portion of the fastener to an extent less than 720 degrees.
- 14. (Currently amended) The support of claim 9 wherein the <u>non-lethal</u> implement delivers non-lethal force from the front of the <u>non-lethal</u> implement and the second channel comprises a second abutment surface that faces a rear surface of the <u>non-lethal</u> implement.
- 15. (Previously presented) The support of claim 9 wherein:
  - a. the support comprises a first portion and a second portion; and
- b. the first fastener mechanically joins the first portion of the support to the second portion of the support.
- 16. (Previously presented) The support of claim 9 wherein:
  - a. the support comprises a first portion and a second portion; and
- b. the second fastener mechanically joins the first portion of the support to the second portion of the support.
- 17. (Currently amended) The support of claim 9 wherein:
- a. the support comprises a first portion retained to the rail and a second portion retained to the <u>non-lethal</u> implement; and

#### **REMARKS**

Upon entry of this Amendment, claims 6 through 17 are pending. Claims 1 through 17 stand subject to restriction as follows: Group I (Claims 1-3), Group II (Claim 4), Group III (Claims 6-8), and Group IV (Claims 9-17).

### Response to Restriction Requirement

The amendment to the claims is believed to place claims 6 through 17 in one Group III for examination. Applicant elects without traverse examination of claims 6 through 17.

#### Conclusion

Reconsideration is respectfully requested. Applicant believes the case is in condition for allowance and respectfully requests allowance of the pending claims.
