The Examiner and the Applicants' representatives Thomas Kowalski, Deborah Lu, and Russell Garman discussed the 35 U.S.C. §112, first paragraph and §103 rejections of record. Regarding the 35 U.S.C. §112, first paragraph rejection, the Examiner and Applicants' representatives conversed about cited reference Argani et al. and its disclosure of successful transformations in several types of Bifidobacterium, as shown in Table 3. Regarding the 35 U.S.C. §103 rejection, the Examiner explained the reasons for issuing the rejection. The Applicants' representatives disagreed with the reasons for the rejection, and will discuss with the Applicant about arguments to address the 35 U.S.C. §103 rejection.
