Continuation of 3. NOTE: the language of the proposed amendment is unclear and requires further consideration. Additionally, the newly claimed language (in surface state of the plate as a base plate) in claims 13 and 23 was not previously presented. Also, this language is somewhat unclear and might raise issues under 112, second paragraph. Accordingly, the proposed amendment requires further consideration and/or search.

Continuation of 11. does NOT place the application in condition for allowance because: since the proposed amendment has not been entered, applicant's arguments regarding the proposed amendment are not persuasive. The Examiner maintains the position set forth in the final office action.
