Continuation of Substance of Interview including description of the general nature of what was agreed to if an agreement was reached, or any other comments: Discussed claimed "each of the keys is lens-shaped". Column 18, lines 14-17 of Lennart discloses the optical or the lens of each of the keys (5) being modified to make any shapes. Applicant agrees that Lennart reads on claims 1 and 13. Applicant proposes to add claimed "the actuators 760" to each of independent claims 1 and 13 to overcome the Lennart reference. However, the status of the application has been made Final. In order to expedite prosecution of this applicant, R.C.E. is going to be filed.
